

# FINAL PLAT



#### - NOTES -

- The purpose of this amended plat of Lot A is to correct the north line dimension of Lot A as shown on the recorded plat in Deed Book 165, Page 78, Scotts Bluff County Register of Deeds Office. This recorded plat shows the north line of Lot A to be "304.4", but this is not possible, as this recorded plat only adjusted a part of the south line of Lot A with the north line of Lot B. No exterior distances or angles changed between the original plat of Lot A, recorded in Deed Book 163, Page 369, and the repist of Lot A is such, the north line dimension should not have changed for Lot A in the recorded in recorded in Deed Book 195, Page 78. As such, the north line olimension should not have repist recorded in Deed Book 195, Page 78. Pield measurement, and previous surveys at this Addition show the actual dimension of the north line of Lot A to be 300.4 feet, as shown on this Amandad Plat.
- Lot A is subject to the Mutual Parking Agreement, recorded in Instrument 2011-6370, but an Addition to the Original Town of the City of Garing, Scotta Bluff County, Nebrasia. en Lote A, B, C, D, & E, Treil Edge Plaza,
