

SURVEYOR'S CERTIFICATE

I, Dennis P. Sullivan, a Nebrasia Registered Land Surveyor, hereby certify that I have surveyed and prepared a plat of LOT 1, BLOCK 1, WILDCAT FLATS SUBDIVISION, situated in part of Government Lots 2 and 3 of Section 5, Township 21 North, Range 57 West of the 6th P.M., Scotts Bluff County, Nebrasia, more particularly described as follows:

Beginning at the North Quarter Corner of Section 5, thence easterly on the north line of Section 5, on an assumed bearing of S87°27'12"E, a distance of 497.98 feet, to the point of intersection with the centerline of the Gering - Fort Laramie Irrigation Canal, as surveyed, thence bearing S40°26'53"W, on said centerline, a distance of 155.77 feet, thence bearing S39°16'02"W, on said centerline, a distance of 283.77 feet, to the point of intersection with a tangent curve to the right, said curve having a central angle of 12°36'10" a radius of 1650.00 feet, a chord bearing of S45°34'07"W and a chord length of 362.20 feet, thence southwesterly on the arc of said curve and said centerline, a distance of 382.93 feet, thence bearing S51°52'11"W, on said centerline, a distance of 200.69 feet, thence bearing N01°59'11"E, a distance of 746.02 feet, to the point of intersection with the north line of Section 5, thence easterly on the north line of Section 5, bearing S87°27'12"E, a distance of 174.00 feet to the Point of Beginning, containing an area of 6.29 Acres, more or less.
