I, Kelly A. Beatty, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed and prepared a plat of LOTS 1 THROUGH 5, BLOCK 1. PORTAL ADDITION, an Addition to the City of Gering, Nebraska, situated in the Southwest Quarter of Section 1, Township 21 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska, more

particularly described as follows:

Beginning at the Southeast Corner of Lot 3A, Block 2, a Replat of Lots 1,2 and 3, Block 2, Pappas Second Addition, to the City of Gering, Nebraska, thence easterly on the easterly extension of the South line of Lot 3A, on a bearing of N 89'54'38"E, a distance of 20.00 feet, thence bearing N 00'05'26"W, on a line being 20.00 feet East of and parallel with the East line of Lot 3A, and northerly extension thereof, a distance of 364.80 feet, thence bearing S 89°54'38"W, on a line being 160.00 feet North of and parallel with the North Right of Way line of "L" Street, as platted, a distance of 400.00 feet to a solution of the street of the stre feet, to a point being 20.00 feet East of the East line of a tract of land as described in Deed Book 186, Page 397, Scotts Bluff County, Nebraska, Register of Deeds Office, thence bearing N 00.05.26.W, on a line being 20.00 feet East of and parallel with said tract of land, a distance of 44.73 feet, thence bearing S 89.58.41.W, on a line being 20.00 feet North of and parallel with the North line of said described tract, a distance of 72.09 feet, to the point of intersection with the East line of Tax Lot 5C, thence bearing S 00'09'08"W, on the East line of said Tax Lot 5C, a distance of 20.00 feet, to the point of intersection with the North line of previously described tract of land, as recorded in Deed Book 186, Page 397, thence bearing N 89'58'41"E, on the North line of said tract of land, a distance of 52.17 feet, to the Northeast Corner of said tract of land, thence southerly on the East line of said tract of land, bearing S 00°05'26"E, a distance of 184.75 feet, to the point of intersection with the North Right of Way line of "L" Street, thence easterly on said North Right of Way line of "L" Street, bearing N 89°54'38"E, a distance of 400.00 feet, to the point of intersection with the northerly extension of the East line of Lot 3A, Block 2, a Replat of Lots 1,2 and 3, Block 2, Pappas Second Addition, thence southerly on said extension line and East line of Lot 3A, Block 2, Pappas Second Addition, bearing S 00°05'26"E, a distance of 204.80 feet, to the Point of Beginning, containing an area of 1.68 acres, more or less.


