

SURVEYOR'S CERTIFICATE



Beatty, a Nebraska Registered Land Surveyor, hereby certify that I have prepared a plat of Lots 9 through 14, Block 1, and Lots 1 through 6, Block 2, Westwood Estates, an Addition to the City of Gering, Scotts Bluff County, Nebraska, situated in the Southwest Quarter of the Southwest Quarter of Section 2, Township 21 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska, more particularly described as follows:

Commencing at the Southeast Corner of the Southwest Quarter of the Southwest Quarter of said Section 2, thence westerly on the South line of Section 2, a distance of 110.00 feet, to the Point of Beginning, thence continuing westerly on the South line of Section 2, a distance of 260.00 feet, thence a deflection angle right 89°46'02", on a line being 370.00 feet West of and parallel with the East line of the Southwest Quarter of the Southwest Quarter of the Southwest Quarter of Section 2, a distance of 515.00 feet, thence a deflection angle right 90°13'58", a distance of 260.00 feet, to the point of intersection with the West Right of Way line of a 20.00 feet alley, as platted in Block 1, Westwood Estates, thence a defelection angle right 89°46'02", on said West Right of Way line of alley, a distance of 515.00 feet, to the Point of Beginning, containing an area of 3.07 acres, more or less.
