SURVEYOR'S CERTIFICATE

l, Kelly A. Beatty, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed and prepared a plat of Lot 8, Block 1, Lot 7, Block 2, Lots 7 — 10, Block 3, and Lots 1 — 5, Block 4, Westwood Estates, an Addition to the City of Gering, Scotts Bluff County, Nebraska, situated in the Southwest Quarter of the Southwest Quarter of Section 2, Township 21 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska, more particularly described as follows:

Commencing at the Southeast Corner of the Southwest Quarter of the Southwest Quarter of Section 2, thence westerly on the South line of Section 2, a distance of 110.00 feet, thence a deflection angle right 89°46'02", a distance of 33.00 feet to the Southeast Corner of Lot 14, Block 1, Westwood Estates, as platted, thence continuing northerly on the East line of Lot 9 through 14, Block 1, Westwood Estates, and on a line parallel to the East line of the Southwest Quarter of the Southwest Quarter of Section 2, a distance of 482.00 feet, to the Northeast Corner of Lot 9, Block 1, Westwood Estates, said corner also being the POINT OF BEGINNING, thence continuing northerly on last described course, and on the West line of a 20.00 feet alley, as platted in Block 1 and Block 3, Westwood Estates, said line being parallel to the East line of the Southwest Quarter of the Southwest Quarter of Section 2, a distance of 518.00 feet, thence a deflection angle left 89°46'02", a distance of 90.00 feet, thence a deflection angle right 89°46'02", a distance of 34.00 feet, thence a deflection angle left 89°46'02", a distance of 170.00 feet, thence a deflection angle left 90°13'58", on a line being 370.00 feet West of and parallel with the east line of the Southwest Quarter of the Southwest Quarter of Section 2, a distance of 552.00 feet, to the point of intersection with the westerly extension of the North line of Lot 6, Block 2, Westwood Estates, said point being 20.00 feet West of the Northwest Corner of Lot 6, Block 2, Westwood Estates, thence a deflection angle left 89'46'02", on the North line of Lot 6, Block 2, and Lot 9, Block 1, Westwood Estates, a distance of 260.00 feet, to the Point of Beginning, containing an area of 3.22 acres, more or less.

That the accompanying plat is a true delineation of such survey drawn to a scale of 100 feet to the inch. That all dimensions are in feet and decimals, that each lot and block has its own number. That the boundary of the plat is shown with a heavy solid line with dashed lines being for orientation purposes only. That all corners found or set are marked as shown.


