

SURVEYOR'S CERTIFICATE

I, M. C. Schaff, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed a tract of land in the Southwest Quarter (SW1/4) of Section 22, Township 23 North, Range 56 West of the 6th P.M., Scotts Bluff County, Nebraska, said tract being more particularly described as follows:

With reference to the point of intersection of the south line of Section 22 and the west line of 13th Avenue, as previously recorded, extended; thence north on the west line of 13th Avenue, extended, a distance of 330.0 feet to the point of beginning; thence continuing north on the west line of 13th Avenue, a distance of 120.0 feet; thence west, parallel to the south line of Section 22, a distance of 168.0 feet; thence South, parallel to the west line of 13th Avenue, a distance of 120.0 feet; thence East, parallel to the south line of Section 22, a distance of 168.0 feet to the point of beginning, containing an area of 0.46 acres more of less, said tract of land is designated as the South 120.0 feet of Tax Lot 34 in the Irregular Tract Book of unplatted lands in the County Surveyor's office of Scotts Bluff County, Nebraska.
