

SURVEYOR'S CERTIFICATE

I, Kelly A. Beatty, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed and prepared a plat of Lot 5 and 6, Block 3, Lot 6, Block 4, and Lots 1 through 4, Block 5, Westwood Estates, an Addition to the City of Gering, Scotts Bluff County, Nebraska, situated in the Southwest Quarter of the Southwest Quarter of Section 2, Township 21 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska, more particularly described as follows:

Commencing at the Northeast Corner of the Southwest Quarter of the Southwest Quarter of Section 2, said point being the TRUE POINT OF BEGINNING, thence westerly on on the North line of the Southwest Quarter of the Southwest Quarter of Section 2, a distance of 370.00 feet, thence a deflection angle left of 90°03′57″, on a line parallel to the East line of the Southwest Quarter of the Southwest Quarter of Section 2, a distance of 256.15 feet, to the point of intersection with the westerly extension of the North line of Lot 5, Block 4, Westwood Estates, thence a deflection angle left of 89°46'20", on said extension line and North line of Lot 5, Block 4, Westwood Estates and the easterly extension thereof, a distance of 170.03 feet, to the point of intersection with the East right of way line of 18th Street, thence a deflection angle right of 89°46'20", on said East right of way line of 18th Street, a distance of 34.03 feet, to the Northwest Corner of Lot 7, Block 3, Westwood Estates, thence a deflection angle left of 89°40'23", on the North line of Lot 7, Block 3, Westwood Estates, a distance of 89.95 feet, to the Northeast Corner of Lot 7, Block 3, Westwood Estates, thence a deflection angle right of 89°40'23", on the East line of Lot 7, Block 3, Westwood Estates, a distance of 29.93 feet, to the point of intersection with the westerly extension of the North line of Lot 4, Block 3, Westwood Estates, thence a deflection angle left of 89°37'37", on said extension line and North line of Lot 4, Block 3, Westwood Estates, a distance of 110.05 feet, to the point of intersection with the East line of the Southwest Quarter of the Southwest Quarter of Section 2, thence a deflection angle left of 90°22'23", on said East line of the Southwest Quarter of the Southwest Quarter of Section 2, a distance of 321.59 feet, to the POINT OF BEGINNING, containing an area of 2.41 acres, more or less.

That the accompanying plat is a true delineation of such survey drawn to a scale of 100 feet to the inch. That all dimensions are in feet and decimals, that each lot and block has its own number. That the boundary of the plat is shown with a heavy solid line with dashed lines being for orientation purposes only. That all corners found or set are marked as shown.
