SURVEYOR'S CERTIFICATE

I. Kelly A. Beatty, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed and prepared a plat of LOTS 1 THROUGH 10, WEBBER MANOR THIRD ADDITION, an Addition to the City of Scottsbluff, Scotts Bluff County, Nebraska, a plat of Vacated Blocks 1, 2 and 4, and Adjacent Alleys in Webber Manor Second Addition, an Addition to the City of Scottsbluff, Scotts Bluff County, Nebraska, and Unplatted land situated in the Southeast Quarter of Section 14, Township 22 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska, with the exterior boundary line of Webber Manor Third Addition more particularly described as follows:
