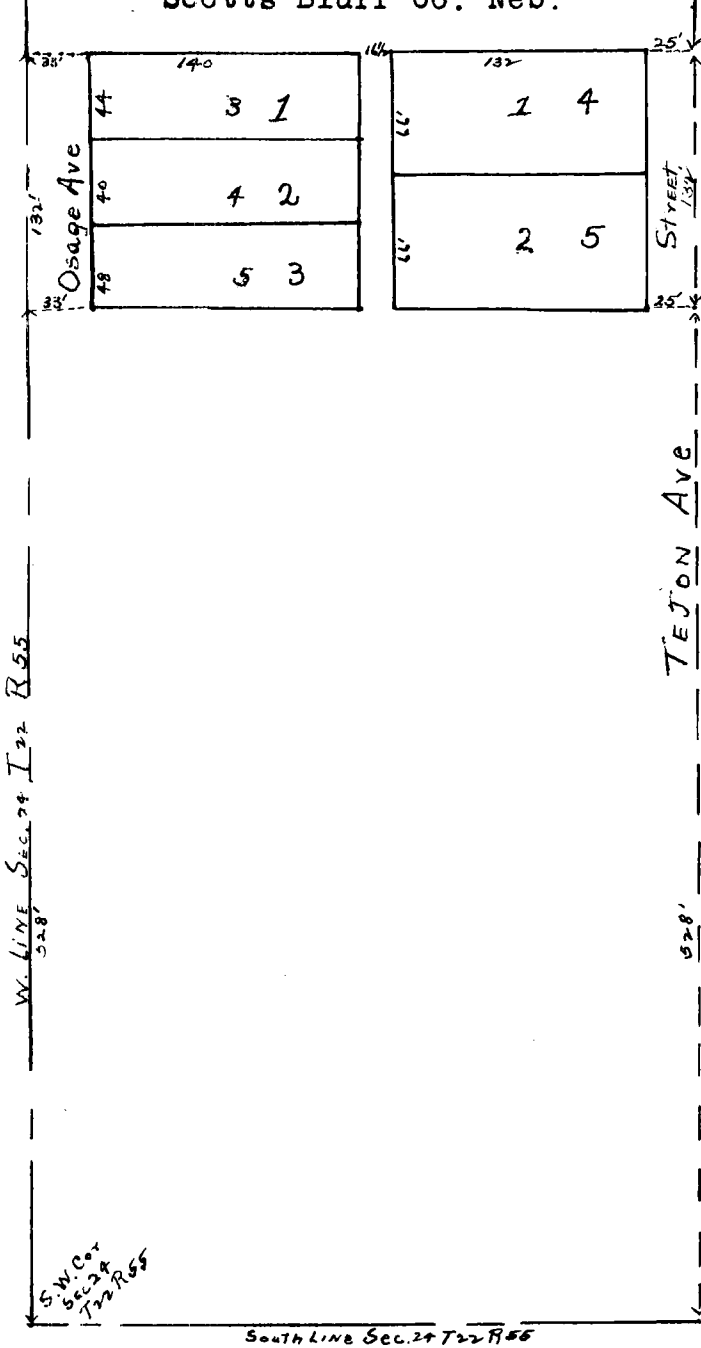

 to the City of Scottsbluff is located as shown

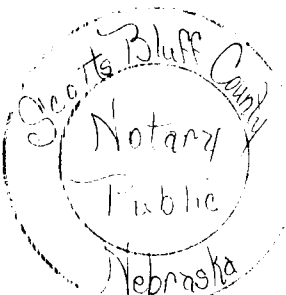
by the foregoing plat and Surveyors Certificate; that I have caused said land to be
