

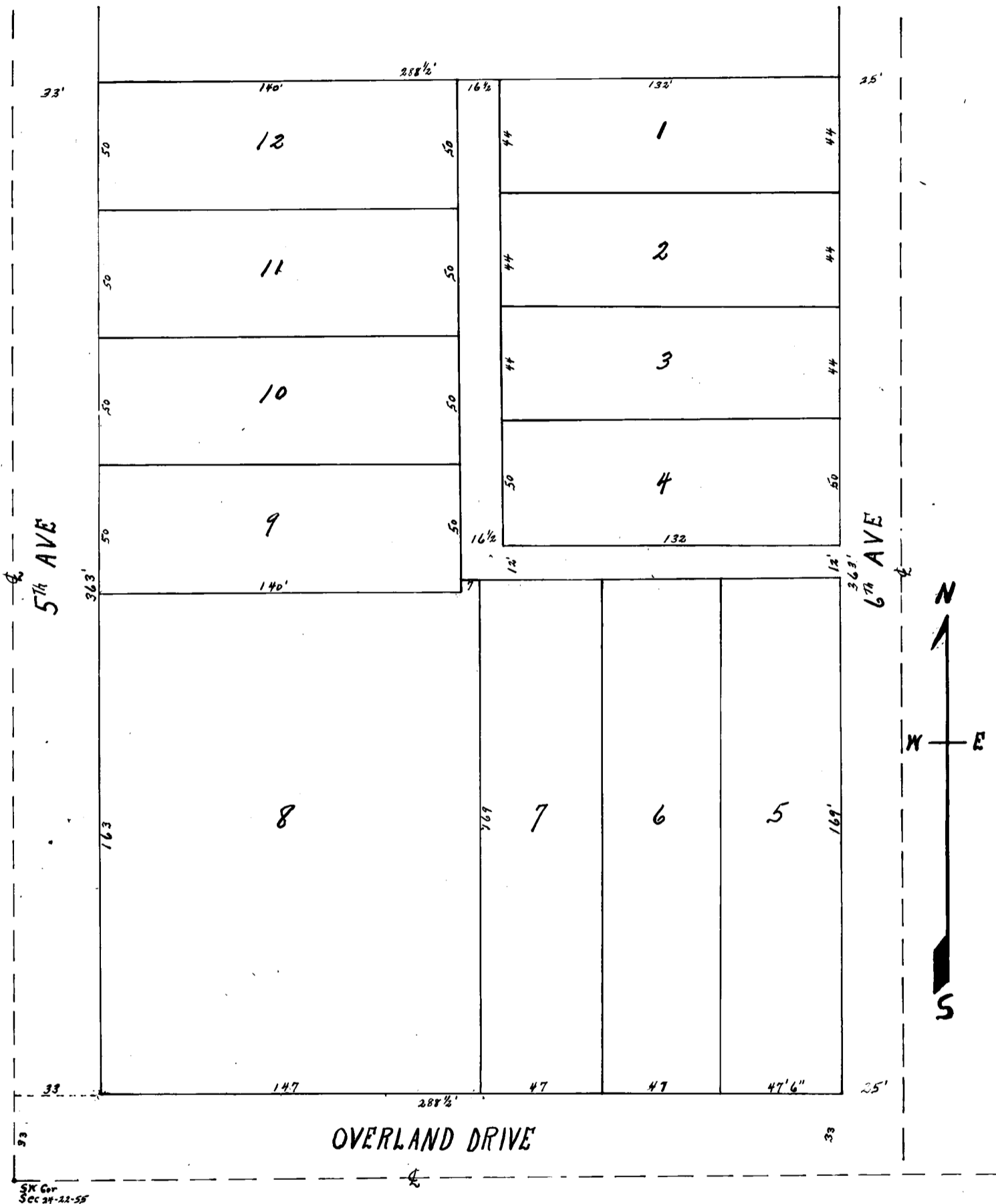

I hereby certify that on the 6th day of September, 1919, I surveyed ROBERTS & WRIGHT ADDITION to Scottsbluff, situated on a part of Sec. 24, Twp. 22 N., R. 55 W. of the 6th P.M., described as follows: Beginning at a point 33 feet East and 33' North of the S.W. corner of Sec. 24, Twp. 22, R. 55 Thence North 363 feet on a line parallel with the West line of said Section, thence East 288 $\frac{1}{2}$ feet on a line parallel with the South line of Sec. 24 thence South 363 feet, thence West 288 $\frac{1}{2}$ feet, to the point of beginning; that the above plat is a correct delineation of said survey drawn to a scale of 50 feet to one inch.

Fir stakes are driven well into the ground at the front corners of each lot. The width of the alleys and the dimensions of the lots are indicated on the plat in feet and fractions, or inches. Each lot bears its own number.
