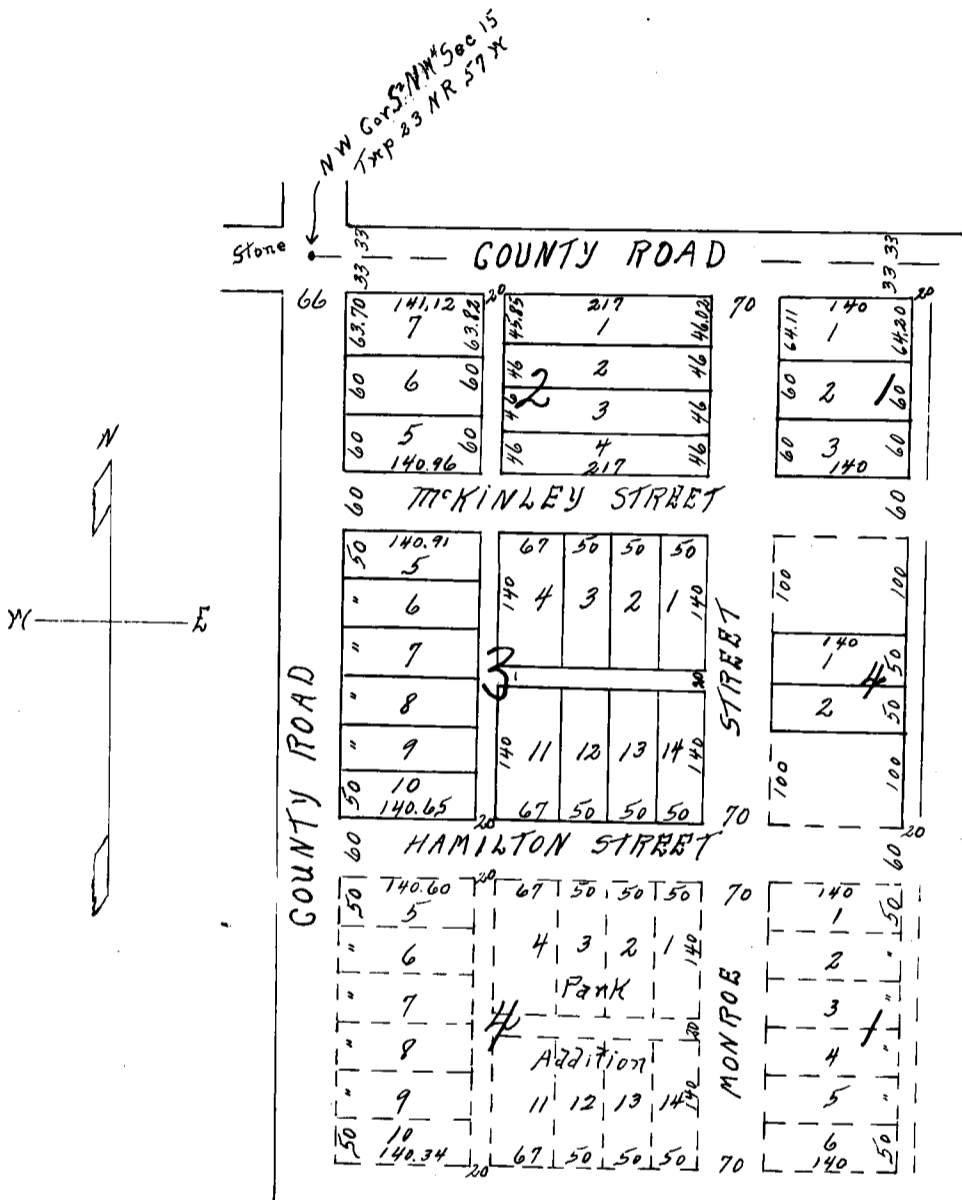

I hereby certify that in the month of January 1920 I surveyed the THIRD ADDITION to the town of Morrill Nebraska situated in Section 15, Township 23 North Range 57 West of the 6th Principal Meridian, Scotts Bluff County, Nebraska as shown by the annexed plat which is a correct delineation of said survey drawn to a scale of 200 feet to an inch.

The streets are continuations of those of the same name in the Park Addition and the First Addition. McKinley street is laid out parallel with Hamilton street.

Cedar stakes are driven well into the ground at the front corners of each lot.

The widths of streets and alleys and dimensions of lots are indicated in feet on said plat.

Each lot and block bears its own number.
