## ORDINANCE # A-74

AN ORDINANCE OF THE VILLAGE OF MORRILL, NEBRASKA, DECLARING THE ANNEXATION OF TERRITORY
DESCRIBED AS "REISING ADDITION" TO THE CORPORATE LIMITS OF THE VILLAGE OF MORRILL, NEBRASKA
AND EXTENDING THE LIMITS OF SAID VILLAGE TO INCLUDE SAID PROPERTY.

WHEREAS a plat of territory lying contiguous to the corporate limits of the Village of Morrill, Nebraska, designated "Reising Addition" and properly subdivided has been filed with the Village Clerk along with a request signed by all of the property owners and inhabitants of said territory requesting that the same be annexed to the Village of Morrill, Nebraska, and whereas a majority of all members of the Board of Trustees have voted in favor of such annexation.


