



I certify that on the 27th day of April 1951, I surveyed Sandbergs First Addition to the City of Gering, Nebraska, located in Tax Lot 52A in the Northwest Quarter ( $NW_{\frac{1}{4}}$ ) Section 2, Township 21 North, Range 55 West of the 6th P.M., more fully described as follows:

Beginning at a point located on the West line of Prohs Addition to the City of Gering, Scottsbluff County, Nebraska, and 140 feet South of Northwest corner, Lot 1, Block 3 Prohs Addition to the City of Gering, Scottsbluff County, Nebraska; thence South for a distance of 390 feet along the West line of Prohs Addition to the North line of Sandbergs Addition; thence West a distance of 266.1 feet; thence South a distance of 100 feet; thence West a distance of 181.5 feet to the East line of Reeder Addition; thence North along the East line of Reeder Addition, a distance of 670 feet to the centerline of "S" Street; thence East a distance of 208.2 feet; thence South a distance of 180 feet; thence East a distance of 240 feet to the point of beginning.
