LANGLEY, a competent surveyor, of Scotts Bluff County, Nebraska, hereby certify that I have surveyed WESTMOOR EIGHTH ADDITION to the City of Scottsbluff, situated on part of the East-half of the Southeast Quarter (E½ SE¼) of Section Twenty-two (22), Township Twenty-five (55), North, Range Fifty-five (55), West of the Sixth (6th) P. M., of Scotts Bluff County, Nebraska, more particularly described as follows: Begin at a point on the North Line of West Overland Drive 1028 feet West and 33 feet North of the Southeast corner of Section 22, T 22 N, R 55 W, of 9 P. M.; thence West 300 feet along the North Line of West Overland Drive; thence North a distance of 1172.7 feet to the West line of 16th Street extended West; thence East on the South Line of 16th Street a distance of 296.1 feet to the West line of Westmoor Second Addition; thence South 1172.7 feet to the point of beginning. That the above plat is a correct delineation of said survey, drawn to a scale of 100 feet to an inch, 3/4" x 24" iron pins are driven into the ground at all corners of the lots as shown.
