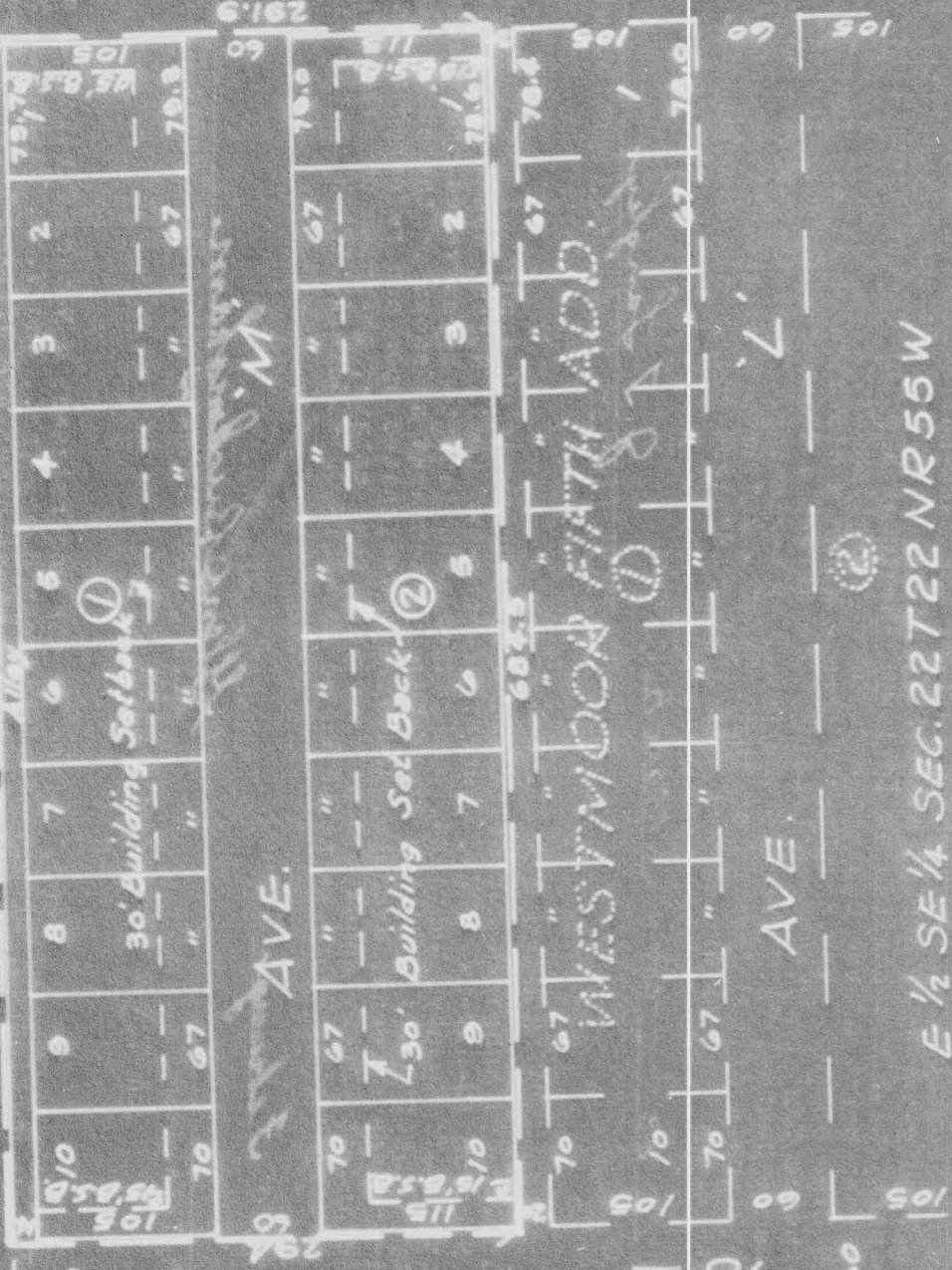

S U B V E Y O R ' S C E R T I F I C A T E

I, J. T. LAMOLEY, a competent surveyor, of Scotts Bluff County, Nebraska, hereby certify that I have surveyed WESTMOOR NINTH ADDITION to the City of Scottsbluff, situated on part of the East-half of the Southeast Quarter (E 1/2 SE 1/4) of Section Twenty-two (22), Township Twenty-two (22) North, Range Fifty-five (55), West of the Sixth (6th) P. M., Scotts Bluff County, Nebraska, more particularly described as follows: Begin at a point on the South line of 20th Street 1319.9 feet West and 75.8 feet South of the East one-quarter (E 1/4) corner of Section 22, T 22 N, R 55 W, of 6 P. M.; thence East 291.9 feet along the South line of 20th Street to the West line of Westmoor Fifth Addition; thence South 684.5 feet parallel to the East line of said Section 22 to the North line of 18th Street; thence West on the North line of 18th Street 294 feet; thence North 645.9 feet to the point of beginning. That the above plat is a correct delineation of said survey, drawn to a scale of 100 feet to an inch. 3/4" x 2 1/4" iron pins are driven into the ground at all corners of the lots as shown. Block corners are marked with 3/4" x 1 1/4" iron rods.
