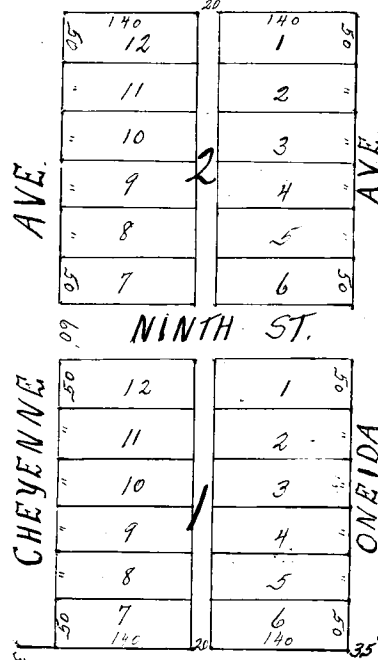

D. 1916, I surveyed Shumway Place an addition to the City of Scottsbluff situated in the SE 1/4 of the NE 1/4 Sec. 23 T. 22 N., R 55W of the 6th Principal Meridian in Scotts Bluff County, Nebraska, as shown on the annexed plat which is a correct delineation of the said survey drawn to a scale of 200' to the inch. The streets and Avenues are extensions of the same name in the Original Town and Addition thereto. Yellow pine stakes are driven well into the ground at the front corners of each lot. The width of the Streets, Avenues and Alley and dimensions of Lots are indicated in feet and decimals by figures in black ink on the annexed plat. Each lot bears its own number.

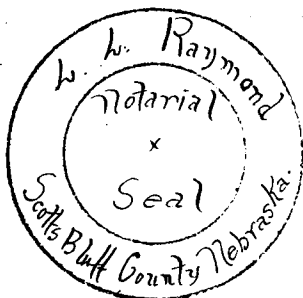
