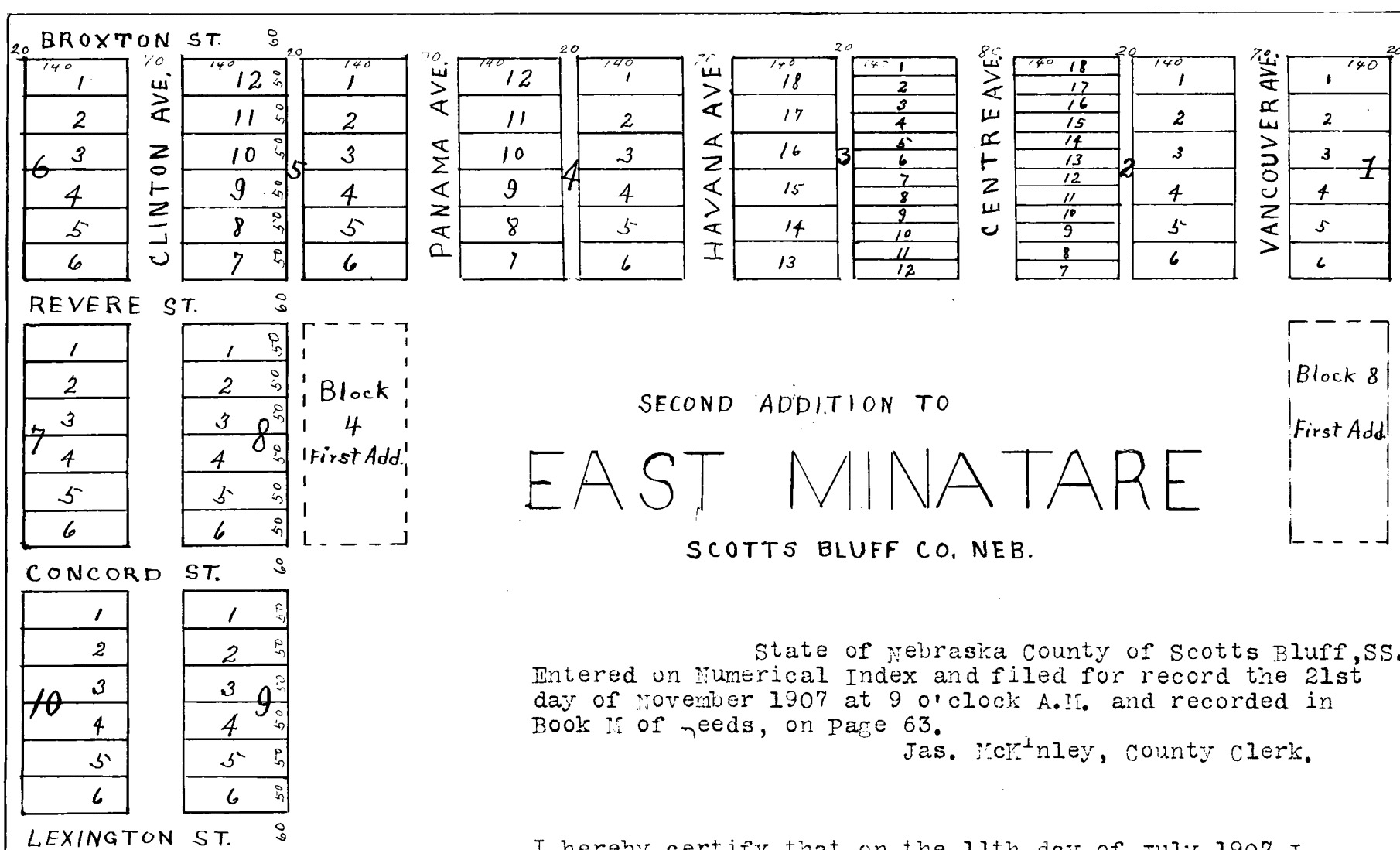

I hereby certify that on the 11th day of July 1907 I surveyed Second Addition to East Minatare situated on a part of the NE $\frac{1}{4}$ of Sec. 7, T. 21 N. R. 53 W. as shown by the foregoing plat which is a correct delineation of said survey drawn to a scale of 200 feet to an inch. The avenues and streets are extensions of those of same names in the original town and first addition, Broxton St is parallel with Reeves St. and Clinton Ave. is parallel with Panama Ave. Burr Oak stakes are driven well into the ground at the front corners of each lot. The width of streets avenues and alleys and dimensions of lots are indicated in feet by red figures. Each lot and block bears its own number.
