Dear Commissioners:

In accordance with section 77-1719.02 R.R.S. 1943 of Nebraska, I am attaching a list of 2025 Distress Warrants, which shows the uncollectible warrants returned by the Scotts Bluff County Sheriff's Department.

On November 1st, 2025, 169 warrants totaling \$114,461.03 were issued. No new warrants were added or issued during the year. Eight warrants were recalled by the Scotts Bluff County Treasurer's Office. Five warrants were returned as uncollectible, totaling \$56,940.34. They are detailed as follows:
